If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®.

I acknowledge that annual membership dues are currently \$555, and first time REALTOR® members are assessed a one-time \$100 application fee. New member dues are prorated back to the date my Alaska Real Estate license became effective with my REALTOR® brokerage, not the date I applied for REALTOR® membership. Upon submittal of my membership application to ABR, I will receive an invoice by email and will submit timely payment. Online payment must be made within 10-days of receipt of my invoice and late payments are subject to a \$50 per month late fee. I understand that the Anchorage Board of REALTORS® does not take payments and does not issue refunds.

Please note, payments to the Anchorage Board of REALTORS® are not deductible as charitable contributions. Payments may, however, may be deductible as an ordinary and necessary business expense.
